- Consider adoption of a Resolution (s) of the Colusa County Board of Supervisors adopting Fiscal Year 2011-2012 Final Budget for the County of Colusa and authorize the Chairman to sign.

Note:

Within the scheduled Public Hearing for Fiscal Year 2011-2012 Budget for the County of Colusa the Board of Supervisors will sit as the governing body of each of the following entities: Air Pollution Control District, the In-Home Supportive Services Authority, the Colusa County Flood Control and Water Conservation District, Colusa County Service Area #1 (Century Ranch), and the Colusa County Service Area #2 (Stonyford). Also, within the scheduled Public Hearing the Board may hear comments on the respective entities. Any member of the general public may appear at the hearing and be heard regarding any item of the budget or for the inclusion of additional items.

Pursuant to Government Code Section 29080 all proposals for the increase or inclusion of additional items shall be submitted in writing to the Clerk of the Board before the close of the Public Hearing.
