In an effort to respond to Governor Newsom's orders and directives to limit physical interaction, **all County buildings will be closed to the public, effective April 13<sup>th</sup>. Colusa County staff will remain working during normal business hours to provide full services.** This modification in business operations protects County employees and the public, while allowing us to continue to serve the community. Due to this building closure, it will be necessary to utilize email, telephone, and on-line services where possible.
