Subject: Colusa County Bridge Street Underground Utility District

Caltrans is preparing to make significant improvements to State Route 20 within the City of Colusa (Bridge Street) between Butte Vista Drive and Market Street. The project will include reconstruction of the roadway, installation of curb, gutter, and sidewalk, as well as undergrounding overhead utilities.

In order to complete the conversion of overhead to underground utilities, PG&E requires that local agencies create a utility district. A small portion of properties affected by this project are in Colusa County, and therefore, the County must create an underground utility district for this area. This district would include properties on the east side of Bridge Street from Lafayette Street to Jay Street.

The district will be entitled the "Colusa County Bridge Street Underground Utility District" and is shown graphically in Figure A. There are a total of 14 parcels that will be included in this District. Table A shows the list of properties and owners that will be affected.

The purpose of creating this district is to allow PG&E to expend their allocations that have accumulated over the years to fund the undergrounding of overhead utilities. Existing overhead connections will all need to be re-configured for underground service connections, and new service panels will need to be installed. All of this is funded with PG&E allocations, and is at no cost to the property owners.

This item is to request the Planning Commission recommend to the Board of Supervisors that the Colusa County Bridge Street Underground Utility District be created.
