THIS CALENDAR IS A SHORT LIST OF IMPORTANT DATES FOR CANDIDATE FILING AND FOR FILING ARGUMENTS IN FAVOR OF OR AGAINST THE CCSD MEASURE. IT IS THE RESPONSIBILITY OF EACH INDIVIDUAL TO MEET ALL DEADLINES AND REQUIREMENTS. THERE IS NO FEE FOR FILING.

<p><b>January 9 – February 3</b> E-113 thru E-88</p>	<p><b>Candidate Filing Period</b> Candidates may obtain and file Declaration of Candidacy and other required documents during this time. Optional candidate statement to be submitted and paid for at time of filing Declaration of Candidacy. No candidate shall withdraw after 5p.m. on the 88<sup>th</sup> day prior to the election.</p>
<p><b>January 9 – 18 (5:00pm)</b> E-113 thru E-104</p>	<p><b>File Arguments For or Against CCSD Measure</b> Between these dates, arguments for or against the measure may be filed. Arguments IN FAVOR OF or AGAINST the district measure, not to exceed 300 words in length. 10 day public examination period begins on the day after the deadline.</p>
<p><b>January 18</b> E-104</p>	<p><b>Impartial Analysis</b> County Counsel to submit Impartial Analysis by this date.</p>
<p><b>January 19 – January 30, (5:00pm)</b> E-103 thru E-92</p>	<p><b>Rebuttals to Arguments For or Against CCSD Measure</b> Between these dates, Rebuttals to Arguments IN FAVOR OF or AGAINST the measure argument may be filed. Not to exceed 250 words in length. 10 day public examination period begins on the day after the deadline.</p>
<p><b>February 9</b> E-82</p>	<p><b>Randomized Alphabet Drawing, 11:00am</b> Randomized alphabet drawing to determine the order in which the candidates will appear on the ballot.</p>
<p><b>March 6 – April 18</b> E-57 thru E-14</p>	<p><b>Write-In Candidate filing period</b> Write-In candidates must file their Statement of Write-In and other forms with the County Elections Office.</p>
<p><b>April 3</b> E-29</p>	<p><b>First Day Ballots may be mailed out.</b> Voter Guide will be included with the mailed ballot.</p>
<p><b>April 17</b> E-15</p>	<p><b>Last Day to Register to Vote</b></p>
<p><b>April 16 – May 2</b> E-14 thru E</p>	<p><b>New Citizen Registration Period</b></p>
<p><b>May 2,</b></p>	<p><b>ELECTION DAY</b> Ballots will be counted after 8pm and unofficial election results posted to the website</p>
<p><b>June 1,</b> E+30 no later than this date</p>	<p><b>STATEMENT OF VOTE TO BOARD OF SUPERVISORS, CERTIFICATES OF ELECTION PREPARED</b></p>
