Chairman Vann welcomes everyone to the Joint Cities and County meeting and speaks to recent accomplishments and progress of the County and Cities noting the progress made in the areas of the Boat Ramp, update of the General Plan, and the ground breaking of the new College and the Community Center in Williams, CA.

Chairman Vann states there will be a short presentation by FEMA regarding upcoming countywide FEMA mapping process and introduces Mr. Scott Rice, of the Department Water Resources and Ms. Kathleen Shaffer, of FEMA.

Chairman Vann makes time for a period of public comment. Hearing none, Chairman Vann closes the period of public comment.

Chairman Vann makes time to discuss Joint Powers Agreement/Bylaws for the Colusa County Economic Development Commission stating the purpose of the agreement is for the members to exercise jointly their common powers to provide for and promote the economic development of the County. She further states she would like all those involved to take a copy of the JPA and review and make comments noting another Joint Cities and County meeting can be held to discuss the agreement further.

Chairman Vann makes time for a presentation by FEMA regarding upcoming countywide FEMA mapping process.

Ms. Shaffer and Mr. Rice speak to the federal efforts under way to revise flood maps throughout the United States, length of the process, how information will be acquired for the mapping, the need for citizens to carry flood insurance due to the new mapping, cost of insurance currently versus cost at a future date, local governments being responsible for levee maintenance, and certified levees verses uncertified levees. Discussion is held, with no action taken.

Ms. Placheck-Fulcher updates the Board of Supervisors on items that pertain to the City of Williams.

Ms. Critchfield updates the Board of Supervisors on items that pertain to the City of Colusa.
