- e. Migrant head start E-Center's last day is October 25th; new option is anyone that works with honeybees will be able to apply.

- f. **AO**-Oral Health – focusing on data collection efforts, outreach to dentists, new position with a lot of work to come, doing oral health ed. at Family action centers
- g. **KW**-PHN – annual flu drive will be Oct 10th from 11-3; county has been allotted flu mist and will be going into the schools to administer
- h. **TF**-River City-No updates from River City; excited to be here-this group is the most robust group she has been involved in.
- i. **GH**- First 5 has been refunded for CalFresh outreach and enrollment; send families to our offices for assistance. This year working with strategies for youth to help create change with parents and community. Can work scope of work into parent community cafe. Social connections, networking in a casual social setting. Just took over a grant from special-ed. to expand AmeriCorps. Working on Talk, Read, Sing campaign – looking at placemats, bus ads, etc. to get to county. Also doing a community needs assessment as well as still doing car seat classes.
- j. **DG**- Still enrolling in Pre-schools, have slots available for children, must be 3 (before September 1st); received small grant for trauma-informed care.
