# Land Conservation Contracts (Williamson Act/Farmland Security Zone) Non-Renewal Process/Instructions

- Complete Notice of Non-Renewal form and have EVERY owner sign. All signatures must be notarized. (A CALIFORNIA ALL PURPOSE ACKNOWLEDGMENT notary form is provided for convenience and may be duplicated as needed.)
  - a. If additional signature sheets are necessary, additional copies may be attached.
  - b. Please note the Community Development Department will obtain the signature of the Clerk of the Board once your form has been submitted.
- 2. Submit completed "Notice of Non-Renewal" form with all original signatures and acknowledgements in person or by mail to:
