QUALIFICATIONS

COLUSA COUNTY BOARD OF EDUCATION

Each member of the board shall be an elector of the trustee area which he represents and shall be elected by the electors of the trustee area.. Ed. Code 1000

(a) Any registered voter is eligible to be a member of the county board of education except the county superintendent of schools or any member of his or her staff or any employee of a school district that is within the jurisdiction of the county board of education. Ed.Code 1006

SCHOOL DISTRICTS

(a) Any person regardless of sex who is 18 years of age or older a citizen of the state a resident of the school district a registered voter and who is not disqualified by the Constitution or laws of the state from holding a civil office is eligible to be elected or appointed a member of a governing board of a school district without further qualifications.

(b) (1) An employee of a school district may not be sworn into office as an elected or appointed member of that school district's governing board unless and until he or she resigns as an employee. If the employee does not resign the employment will automatically terminate upon being sworn into office. Ed. Code 35107

The candidate must reside in the trustee area which he or she represents. Ed. Code 5030

YUBA COMMUNITY COLLEGE DISTRICT

Candidates must be a registered voter of the district residing within the trustee area

FIRE PROTECTION DISTRICTS

Each member of the district board shall be a registered voter of the district.

CORTINA COMMUNITY SERVICES DISTRICT

No person shall be a candidate for the board of directors unless he or she is a voter of the district

MAXWELL PARKS AND RECREATION DISTRICT

No person shall be a candidate for the board of directors unless he or she is a voter of the district

MAXWELL PUBLIC UTILITY DISTRICT

A director at large shall be a resident and qualified elector (registered voter) of the district.
