**STATEWIDE GENERAL ELECTION**

**2022 - CALENDAR YEAR**

<b>Early June 2022</b>	Suggested time for jurisdictions holding elections in November to pass a resolution that 1) orders the election; 2) requests the Colusa County Elections Department to conduct the election; 3) consolidates it with any other jurisdiction holding an election on that same day; 4) provides office to be filled (number of seats and terms); 5) includes notice of how a tie vote will be resolved; 6) State if the candidate or the district will pay for the publication of the optional 200 word candidate statement.

<b>June 29<sup>th</sup> – July 13<sup>th</sup></b> (E-127- E-113)	<b>Cities to publish Election Notice</b>
<b>July 6<sup>th</sup></b> (E-125)	<b>Special Districts &amp; Cities Deliver Notice of Election to County Clerk</b> Last day for district secretaries and City Clerks to deliver Notice of Election listing the elective offices to be filled and any measure (if known at the time), to be voted on and to <b><u>deliver a map of the District or City boundaries to the Elections Department.</u></b> <b>Cities and special districts should include notice of how a tie vote will be resolved.</b> 10509, 10522, 10551, 15651
<b>July 8<sup>th</sup></b> (E-123)	<b>Schools to Deliver Specifications of the Election Order to County Clerk</b> Last day for a school board to deliver a resolution known as the "Specifications of the Election Order" and file it with the county Superintendent of Schools and county elections official, stating the date and purpose of the election. <b>Specifications should include how a tie vote will be resolved.</b> Deliver a map of the school district boundaries to the Elections Department. Ed. Code 5322 & 5016
<b>July 11<sup>th</sup> – August 10<sup>th</sup></b> (E-120 thru E-90)	<b>NOTICE OF ELECTION</b> Between these dates the County Clerk to publish a Notice of Election containing the date of the election, the offices to be filled, where nomination papers are available, and the deadline for filing Declarations of Candidacy. Notice of central counting place may be combined with this notice. ED 5363, EC 12109, 12112, 12113
<b>July 18<sup>th</sup> – August 12<sup>th</sup></b> (E-113 – E-88)	<b>Candidate Filing Period</b> Nomination Papers (cities), Candidate Statement of Qualifications, FPPC Form 700, Ballot Designation Worksheet, FPPC campaign/financial statements, Declaration of Candidacies are due at this time. Forms are obtained from and filed with the county elections office. Candidates for city offices will file with the city clerk.
<b>August 13<sup>th</sup> – August 17<sup>th</sup></b> (E-87 – E-83)	<b>Candidate Filing Period Extension – IF INCUMBENT DOES NOT FILE</b> If applicable, the extended filing period is only open to non-incumbents. If the incumbent fails to file by 5:00p.m. on August 12 <sup>th</sup> , then, the filing period is extended and open ONLY to non-incumbents. No extension If incumbent files by August 12 <sup>th</sup> .
<b>August 18<sup>th</sup></b> (E-82) 11:00am	<b>Random Alpha</b> Randomized alphabet drawing to determine the order of candidates on the ballot.
<b>Sept. 12<sup>th</sup> – October 25<sup>th</sup></b> (E-57 – E-14)	<b>Write-in Period</b> Nomination Petitions to become a qualified write-in candidate shall be filed during this period.
<b>October 10<sup>th</sup></b>	<b>Vote by Mail Ballots Mailed no later than this date</b>
<b>October 24<sup>th</sup></b> (E-15)	<b>15 Day Close</b> Standard voter registration deadline
<b>October 25</b>	<b>Conditional Voter Registration begins</b>
<b>November 8, 2022</b>	<b>Election Day (polls open 7 a.m. to 8 p.m.)</b>
